

BAREFOOT ADVENTURES LIABILITY WAIVER AND RELEASE FORM

Acknowledgment of Risk:

I, the undersigned, understand and acknowledge that participating in hiking and scuba tours involves inherent risks, including but not limited to:

Hiking Risks:

- Physical exertion
- Slips, trips, and falls
- Unpredictable weather conditions
- Encounters with wildlife
- Natural hazards (e.g., rocks, roots, streams)
- Remote locations without immediate access to medical facilities

Scuba Diving Risks:

- Drowning
- Decompression sickness (the bends)
- Equipment failure
- Marine life encounters (e.g., stings, bites)
- Barotrauma (pressure-related injuries)
- Navigation hazards (e.g., getting lost underwater)

Release of Liability:

In consideration of being allowed to participate in the hiking and scuba tours, I, for myself and on behalf of my heirs, assigns, personal representatives, and next of kin, hereby release, indemnify, and hold harmless BAREFOOT ADVENTURES, its officers, officials, agents, and/or employees, other participants, sponsors, advertisers, and, if applicable, owners and lessors of premises used to conduct the event (collectively "Releasees"), with respect to any and all injury, disability, death, or loss or damage to person or property, whether arising from the negligence of the Releasees or otherwise.

Medical Treatment:

I hereby consent to receive medical treatment deemed necessary if I am injured or require medical attention during my participation in the hiking or scuba tours. I understand and agree that I am solely responsible for all costs related to such medical treatment, medical transportation, and/or evacuation.

Photographic Release:

I grant BAREFOOT ADVENTURES the right to take photographs and videos of me during the hiking and scuba tours and to use these images for promotional purposes, including but not limited to social media, website, and marketing materials.

Personal Responsibility:

I certify that I am physically fit and have no medical conditions that would prevent me from safely participating in the hiking and scuba tours. I agree to follow all instructions and safety guidelines provided by the tour guides and staff of BAREFOOT ADVENTURES.

Parental/Guardian Consent (for participants under 18):

As the parent or guardian of the minor participant, I consent to their participation in the hiking and scuba tours and agree to all the terms of this waiver.

Acknowledgment of Understanding:

I have read this liability waiver and release form, fully understand its terms, and understand that I am giving up substantial rights, including my right to sue. I acknowledge that I am signing the agreement freely and voluntarily, and intend by my signature to be a complete and unconditional release of all liability to the greatest extent allowed by law.

Severability:

If any part of this waiver is found to be unenforceable, the remaining sections will remain in effect.

Jurisdiction and Governing Law:

This agreement is governed by the laws of Puerto Rico, and any legal proceedings must be brought in Puerto Rico.
